## **General Instructions**

### **Credit Calculation Procedures**

#### **Residential Homestead Market Value Credit -**

**TMV equal to or less than 76,000**

$$\text{TMV} * .01 * .4 = \text{Credit Amount}$$

**TMV greater than 76,000**

$$(76,000 * .01 * .4) - ((\text{TMV} - 76,000) * .0009) = \text{Credit Amount}$$

#### **Agricultural Homestead Market Value Credit -**

**TMV equal to or less than 115,000**

$$\text{TMV up to 115,000} * .01 * .3 = \text{Credit Amount}$$

**TMV greater than 115,000 and less than or equal to 345,000**

$$\$345 - 0.05\%(\text{Total Taxable Market Value} - \$115,000) = \text{Credit Amount}$$
