Benefit Determination Hearing and Discussion for Otter Tail County Drainage System No. 16

NOTICE IS HEREBY GIVEN TO THE PROPOSED BENEFITED PROPERTY OWNERS OF OTTER TAIL COUNTY DRAINAGE SYSTEM NO. 16 that the Otter Tail County Drainage Authority will hold a public hearing at 7:00 p.m. on Thursday, April 2, 2009, in Battle Lake Public School's Royal S. Broberg Memorial Auditorium in Battle Lake (located at 402 West Summit Ave), Minnesota for the purpose of discussing and considering the preliminary Ditch Viewers' Report of Benefits and Damages.

The Otter Tail County Board of Commissioners, drainage authority for County Drainage System No. 16, was approached by property owners and persons affected by the system with regard to the possibility of repair and/or maintenance work being done on the system.

Per a document dated May 2, 1906 County Drainage System No. 16 is described as commencing at a point in the west end of a swamp slough located in Sections 25 and 36 of Clitherall Township and Sections 30 and 31 of Nidaros Township and runs in a westerly direction into Crane Lake: thence from the north side of Crane Lake following and running along the present stream which forms the outlet of said Crane Lake and running through the northwest quarter of Section 25 of Clitherall Township and into Clitherall Lake, and thence following and running along the stream that forms the outlet of said Clitherall Lake through Sections 11 and 2 of Clitherall Township and into West Battle Lake, and there terminating with its outlet into said West Battle Lake in Clitherall Township.

The Otter Tail County Board of Commissioners, acting in their capacity as Drainage Authority, at a meeting held on Tuesday, January 8, 2008 decided to have benefits and damages re-determined for Otter Tail County Drainage System No. 16. The preliminary Ditch Viewers' report was filed with the Otter Tail County Auditor on Tuesday, December 2, 2008 and is available for public inspection during normal business hours Monday through Friday at the Otter Tail County Auditor's office located at 500-600 Fir Ave W., Fergus Falls, MN and is also available on Otter Tail County's Web Site at <http://www.co.ottertail.mn.us>.

The preliminary Ditch Viewers' report states that 3,906 acres of private lands, 109 acres of Township roads, 28 acres of County roads and 42 acres of State roads will be benefited by Otter Tail County Drainage System No. 16. The benefits assigned to the private lands total \$23,514,801, to the City of Clitherall total \$30,400, to the Township roads total \$6,543, to the County roads total \$1,668 and to the State road total \$2,532. These benefited properties are located within Sections 1, 2, 3, 4, 9, 10, 11, 12, 13, 14, 15, 16, 22, 23, 24, 25, 26, 27, 34, 35 and 36 of Clitherall Township, Sections 5, 6, 7, 8, 18, 19, 20, 29, 30, 31, and 32 of Nidaros Township, Sections 5, 6, 7, and 8 of Leaf Mountain Township and Section 1 of Eagle Lake Township.
